## **COLA Increase - Social Security**



Approximately 70 million Americans will see an 8.7% increase in their Social Security benefits and Supplemental Security Income (SSI) in 2023. Federal benefit rates increase when the cost-of-living rises, as measured by the Department of Labor's Consumer Price Index (CPI-W).

### **Contribution Limits**

2023 Updated Contribution Limits:

- 401(k) contribution limit = \$22,500 (an increase from \$20,500 in 2022)
- IRA Contribution Limit = \$6,500 (under 50 years old) and \$7,500 (over 50 years old)
- Roth IRA income phase-out limits = \$138,000 \$153,000 (for single filers) and \$218,000 \$228,000 (for married couples)
